

Encompass Health to construct 40-bed inpatient rehabilitation hospital in Toledo, Ohio

Rehabilitation hospital expected to begin providing services in late 2020

BIRMINGHAM, Ala., Nov. 13, 2019 /PRNewswire/ -- Encompass Health Corp. (NYSE: EHC) today announced its plans to build a freestanding, 40-bed inpatient rehabilitation hospital in Toledo, Ohio near the intersection of Monroe Street and Secor Road.

Complementing local acute care services, the hospital, which is expected to open in late 2020, will care for patients recovering from a variety of debilitating illnesses and injuries including strokes and other neurological disorders, brain injuries, spinal cord injuries, amputations and complex orthopedic conditions. It offers physical, occupational and speech therapies as well as 24-hour nursing care that aim to restore functional ability and quality of life.

Our care model and hospital have been designed to prepare patients for what comes next on their road to recovery," said Troy DeDecker, president of Encompass Health's central region. The hospital will feature a large therapy gym, advanced rehabilitation technologies, an activities of daily living suite, cafeteria and dining room, pharmacy and courtyard.

It will become part of Encompass Health's national network of inpatient rehabilitation hospitals and home health and hospice agencies. The Company's Ohio footprint includes inpatient rehabilitation hospitals in Cincinnati, Dayton and Westerville and a home health location in Canton.
