

## Encompass Health announces preliminary plans to build a 60-bed inpatient rehabilitation hospital in Avondale, Arizona

BIRMINGHAM, Ala., Feb. 15, 2024 /PRNewswire/ -- Encompass Health Corp. (NYSE: EHC) today announced preliminary plans to build a freestanding, 60-bed inpatient rehabilitation hospital in Avondale, Arizona. The hospital will be located within The District at Crystal Springs development at the southwest corner of Avondale Boulevard and McDowell Road.

The hospital will serve patients recovering from debilitating illnesses and injuries, including strokes and other neurological disorders, brain injuries, spinal cord injuries, amputations and complex orthopedic conditions. In addition to 24-hour nursing care, the hospital will offer physical, occupational and speech therapies to restore functional ability and quality of life. Care will be provided by highly specialized nurses, therapists and physicians.



The hospital will feature private patient rooms, a spacious therapy gym with advanced rehabilitation technologies and an activities of daily living suite, dining room, pharmacy and therapy courtyard.

"We are excited to bring much-needed inpatient rehabilitation services to Maricopa County," said Kim Steward, president of Encompass Health's West region. "The hospital will provide high-quality, compassionate and individualized care close to home, helping patients regain the strength and function needed to return to the community at their highest level of independence."

The hospital will be part of Encompass Health's national network of rehabilitation hospitals, and it will be Encompass Health's seventh hospital in Arizona.
